I have been to the Mount laurel, Manahawkin, and Waretown police. There is not a law they can charge her with.

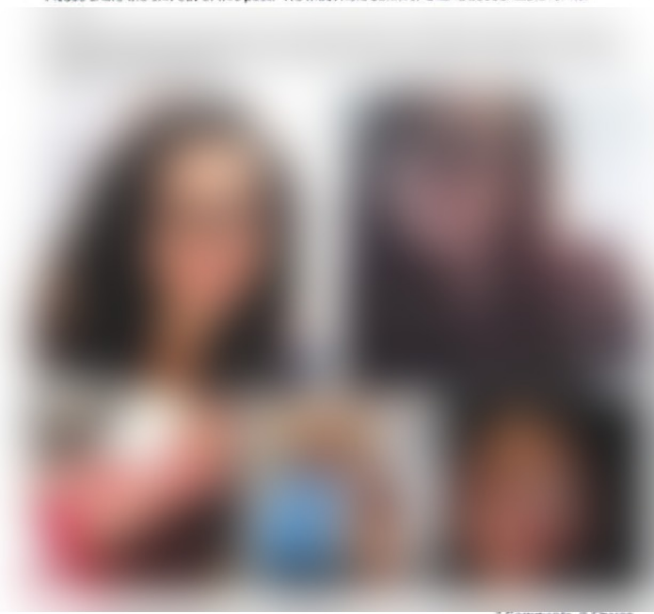
