THE (C) CONTACTED THIS AGENCY AND REQUESTED A KEEP THE PEACE ESCORT TO MEET WITH DYFS. THE (C) STATED THAT HE WAS BEING ACCUSED OF SEXUAL ASSAULT ON A CHILD. PATROL CONTACTED DYFS AND SPOKE WITH TERRANCE CAMPBELL WHO STATED THAT THE (C) WOULD ONLY CONDUCT AN INTERVIEW WITH POLICE PRESENCE. DYFS CAME TO THIS AGENCY AND CONDUCTED THE INTERVIEW.

THE (C) CONTACTED THIS AGENCY AND REQUESTED POLICE AT HIS HOME TO RECORD AN INTERVIEW WITH DCC & P.

PATROL CONTACTED THE (C) CODE 4 AND HE STATED THE (O) WANTED TO COME TO HIS HOME TO SPEAK WITH HIM ABOUT AN ALLEGATION OF SEXUAL ASSAULT. THE (C) PROVIDED THE NAME OF THE (O) AS TERRANCE CAMPBELL

THE (C) STATED CAMPBELL WAS FROM THE DCC&P AND WANTED TO INTERVIEW HIM AT HIS HOME. THE (C) ADVISED HIM HE WOULD SPEAK TO CAMPBELL AT HIS HOME BUT HE WOULD SPEAK TO HIM AT POLICE HEADQUARTERS SO IT COULD BE RECORDED.

PATROL SPOKE TO CAMPBELL WHO STATED HE WAS FROM THE BURLINGTON COUNTY DCC&P. HE RECEIVED A COMPLAINT 02/04/2022 IN REGARDS TO A SEXUAL ASSAULT OF CONTACT. HE THEN INFORMED PATROL HE CONDUCTED AN INTERVIEW WITH THE VICTIM AND CONCLUDED THE ALLEGED COMPLAINT DID NOT OCCUR AND STATED THIS WAS NO LONGER A CRIMINAL INVESTIGATION. CAMPBELL STATED HE WANTED TO SPEAK WITH THE (O) AND WHAT SEEMED HE WANTED TO CONCLUDE HIS CASE.

PATROL OFFICER 327 AND 300 RECORDED ON BODY CAMERA IN THE MAIN LOBBY A CONVERSATION WITH THE (C) ON 300 CAMERA AND THEN WITH THE (C) AND CAMPBELL ON 327 BODY CAMERA.
